

2024 SOAP Virtual Highlights June 10-11, 2024

Target Audience

This meeting is intended for Anesthesiologists, Anesthesiologists Assistants, CRNAs, Nurses, Resident/Fellows, and Medical Students interested in the recent advances in obstetric anesthesia and the application of these advances to their practice.

Objectives

At the conclusion of this activity participants will:

1. Improve the care of women during, pregnancy, labor, delivery, and the early postpartum period by hearing what they each have to say and acting upon their observations. To understand the importance of shared decision-making between patient and caregiver, and to respect patient autonomy. Language barriers contribute to the problems we face and so comprehensive and easily accessed translation services will assist in understanding a patient's needs, concerns and answering questions.
2. To understand the issues surrounding anesthetic management for intrapartum cesarean delivery and how early neuraxial analgesia, with regular monitoring for efficacy and side-effects, can help prevent the need for general anesthesia in this setting.
3. To help reduce the risk of aspiration pneumonitis by revisiting the reasons for fasting guidelines in obstetric anesthesia. In turn, participants can go on to education other caregivers at their own institutions.
