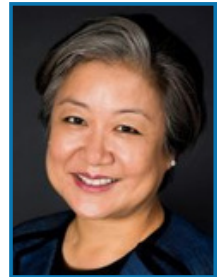

Members have an opportunity to share their meaningful perspectives through the triannual **SOAP Newsletter** publication or network with their colleagues through **Tradewing**, the new online SOAP Community Platform that is designed for clinical discussions, resource distribution, and sharing of news-worthy events and publications.

Our society continues to grow, now with over 2,000 members; our goal is to reach and impact anesthesiologists and health care professionals caring for the pregnant patient globally, at all stages of their career. The society infrastructure supports the personal and professional development of our members with exciting new and ongoing initiatives. We are also continuing with other ongoing educational programs:

- The **Fellows Webinar Series** is a virtual learning opportunity, produced in partnership with *OpenAnesthesia*, designed for fellows in obstetric anesthesiology programs. Lectures are available online for all, archived for long-term reference.
- The **Simulation of the Month (SIMOM)** is designed for multidisciplinary obstetric team training in your simulation lab or in-situ in your labor unit. Scenarios include supportive material for pre-briefing, debriefing and feedback.
- The **Point-of-Care Ultrasound (POCUS) E-learning Series** presents a quarterly case-based lesson on concepts ranging from basic ultrasound principles to image acquisition techniques and discussion of specific pathologies.

The **SOAP Fundamentals** program successfully debuted in spring 2023 with a virtual offering of education content configured for low-resource regions where obstetric anesthesia is limited or unavailable.

In addition to the development of educational content for members and health care teams, SOAP is committed to being the principal voice for obstetric anesthesiology and supporting our patients and their families through a **new patient facing website**. Scheduled to debut in 2024, this patient facing website will be the ultimate guide, aiming to share clinical information, answer frequently asked questions, and deter misinformation and misperceptions surrounding the practice of obstetric anesthesiology.

SOAP is committed to diversity and inclusivity within our organization. All members in leadership positions (Board of Directors, Committee, and Subcommittee members) engage in Diversity, Equity, and Inclusivity (DEI) training modules that feature DEI for the organization, health care teams, and institutions. The **Diversity and Inclusivity Committee** with associated subcommittees are pursuing the following goals: assessing the degree of diversity and inclusivity within our organization to guide active initiatives; creating an environment where all members have an equal opportunity to succeed and be heard; supporting scholarship, research and education that address inequities in peripartum care; sharing resources for individuals and institutions to promote diversity and inclusivity; establishing partnerships and supporting policies that address racial and ethnic disparities in pregnancy-related outcomes.

The **SOAP Diversity & Inclusivity Mentored Grants** are designed to support mentor/mentee pairs that have proposed projects related to DEI research, education, or professional development. Application deadline for the SOAP Diversity and Inclusivity Mentored Grants is March 28, 2024 at 11:59pm Eastern.

Nominees for the **SOAP Diversity and Inclusivity Award** are being accepted through March 1, 2024. This award recognizes outstanding obstetric anesthesiologists who have acted to address racial and ethnic disparities in maternal health outcomes and made significant contributions to increasing diversity and inclusivity of the anesthesiology workforce through their scholarship, mentorship and leadership.

Our vision of “safe and equitable care for women and newborns everywhere” drives our continued pursuit of obstetric anesthesia excellence. **Research** remains a core pillar of our society’s efforts to improve care. SOAP is excited to offer a joint **SOAP-FAER Mentored Research Training Grant (MRTG)** that provides a \$250,000 award, disbursed over two years, to support the development of obstetric anesthesiology and perinatology physician-investigators. The **SOAP Research Network Symposium** provides a forum for members to discuss interesting research ideas, develop rigorous study designs, share expertise, and recruit collaborators. We look forward to the Research Network Symposium at the 2024 SOAP Annual Meeting. Proposal submissions will be accepted through February 15, 2024 for this year’s Annual Meeting symposium.

This year, SOAP embarks on its first **Endowment Fund Campaign**, aiming to support exceptional scientific investigations, to promote the value of obstetric anesthesia expertise, and to disseminate our knowledge to our multidisciplinary colleagues and patients globally through a sustainable funding source – guided by our mission to “advance and advocate for the health of pregnant women and their babies.” Campaign funds will be invested, and the in-perpetuity proceeds used in three focus areas: 1) individual-led research, 2) society-led research, and 3) patient-facing education. Stay tuned for more information about this at our Annual Meeting!

Denver, Colorado is the setting of our upcoming **2024 SOAP Annual Meeting** centered on the theme, “Focusing on the Patient: Improving Individual Outcomes & Experiences.” The Annual Meeting and Live Events Committee, led by Dr. Rebecca Minehart, has compiled an incredible schedule of enlightening educational content. THE SOAP STATE REPRESENTATIVE INITIATIVE: ESTABLISHING A NETWORK TO ENHANCE MATERNAL CARE

“Why are you doing an OB anesthesia fellowship? There’s no need for that.” This message is commonly directed toward residents who are considering fellowship pathways. However, there’s never been a more important time to pursue fellowship training in obstetric anesthesiology. The maternal mortality rate in the United States (US) continues to increase every year; reported as deaths per 100,000 live births, the maternal mortality ratio (MMR) rose from 17.4 in 2018 to 23.8 in 2020.¹ Even more alarming, for Black women in 2020 it was 55.3 vs. 19.1 if you were white. Obstetric anesthesiologists are poised to address maternal mortality and inequity through applying a unique skillset that emphasizes risk assessment, preparedness, critical care, opioid exposure, crisis management and postpartum recovery.

We need not reinvent the wheel. What has been a pioneering success in the United Kingdom, the MBBRACE-UK, can be mimicked in the US. However, efforts must be organized on a smaller, more trackable scale. The California Maternal Quality Care Collaborative (CMQCC) has proven that a state-level approach to maternal mortality and morbidity reduction works. With state-wide surveillance and focus, maternal mortality rates in California have dropped in comparison to the rest of the US.² There are other examples of state-level efforts to lower severe maternal morbidity (SMM). A 2018 analysis of SMM in Illinois identified higher rates among non-Hispanic Black multiparous women, age 35 or older, publicly insured, with inadequate prenatal care.³ Driving sources of SMM were hemorrhage and hypertensive disorders of pregnancy. Almost half of cases had opportunities for improved care to alter outcomes, most commonly involving both intrapartum (9%) and postpartum (10%) healthcare professional factors.

Nearly every state’s Department of Public Health in the US has a maternal morbidity and mortality review committee (MMMRC). The Centers for Disease Control has established funding in 31 states to integrate a common reporting tool called the Maternal Mortality Review Information App, or MMRIA.⁴ This tool allows data collection about maternal deaths to be standardized across states.

SOAP members are unified in their passion for obstetric anesthesiology. Our members catalyze research to define optimal and safe obstetric anesthesia care. They are represented in multidisciplinary initiatives such as the National Partnership for Maternal Safety, an organization that has released pivotal safety bundles that all maternity units should integrate to manage hemorrhage, hypertension, and other morbidity more safely. Many states have established Perinatal Quality Initiative Networks to disseminate such bundles and help maternity centers establish quality metrics and reporting.

How do obstetric anesthesiologists access the wealth of information on best practices that is distilled from research presented at SOAP and elsewhere? How can we best distribute the evolving tools that are created for safer maternal care? How can we find state-level, relevant outcome data to focus our efforts and improve maternal care?

These questions and the urgent state of maternal mortality and morbidity in the US catalyzed the SOAP Board of Directors to launch the SOAP State Representative Initiative in 2022. Dr. Farber and Dr. Kjaer first reached out to engaged SOAP members across the country to identify at least one SOAP member to represent every state in the US. These SOAP State Representatives were then provided a list of hospitals in their state performing > 1000 deliveries per year, based on data provided by the American Hospital Association for 2020. State Reps were asked to confirm the contact information for the OB anesthesia



representation on their state's MMMRC. By the spring of 2023, OB anesthesia service chiefs were identified at 472 (41%) of the 1,139 hospitals, building a professional network connecting clinical OB anesthesia leaders, both within and outside their states. The longer-term goal for the SOAP State Representative Initiative is for SOAP to reach more front-line providers and expand evidence-based practice.

Are you curious about hospital demographics – provider types, delivery volume, and actual needs assessment – throughout our country? How about the current status of OB Anesthesia representation on each state's MMMRC?

There is exciting progress being made! These data will be presented at SOAP 2024 in Denver, Colorado. Join us to learn more about the SOAP State Rep Initiative and how you can be actively involved. With the SOAP State Rep Initiative, the passion that SOAP members bring to OB anesthesia care and how we function as a community now has a place to call home. The task at hand, to do all we can do to lower maternal morbidity and mortality, is clearly defined.

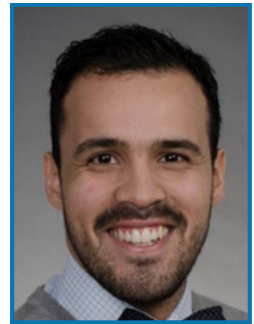

The next annual meeting is just around the corner and SOAP members will have an even bigger spotlight. In November of last year, an open invitation was sent to all membership to submit proposals for podium presentations and panels for the annual meeting. The initiative was spearheaded by the Annual Meeting and Live Events Committee in response to feedback from members evaluating past annual meetings. The intent was to broaden the pool of speakers and showcase the talent we have within the organization. The theme for this year's annual meeting is "Focusing on the Patient: Improving Individual Outcomes and Experiences;" and incorporating members' suggestions complements and enhances the educational content of the meeting.

Members were asked to provide a brief description and overview of their proposed topic, along with learning objectives and format, both for main podium individual presentations and panels. We were lucky to receive 24 robust proposals that were evaluated by the Annual Curricular Subcommittee. These proposals were assessed following an objective rubric which considered interest to the general obstetric anesthesia community, clarity of the learning objectives, alignment with the theme of the annual meeting and range of diversity and experience of the faculty presenting the submission.

A total of 5 presentations were accepted for the in-person meeting and 3 were accepted for the Virtual Highlights session, to be broadcasted in June 2024. The presentations you will get to enjoy in the in-person meeting cover a wide range of topics, including the comprehensive management of PDPH; research into uterine atony; pain and PTSD after cesarean delivery; addressing disparities in maternal care; and how SOAP members can be valuable advocates and members of State Maternal Mortality Review Committees. These panels will feature both national and international speakers and promise to be engaging and constructive for all SOAP members. For the virtual highlights, a combination of presentation and panels will describe how to implement simulation into your daily practice; how to establish obstetric anesthesia consultation services; and how transformational state initiatives can decrease maternal morbidity and mortality.

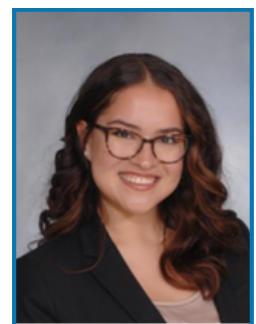

Dr. Lydiesther Martinez has been a strong pillar and advocate for the Spanish-speaking community. She is a powerhouse for change in all settings, whether it is through political advocacy, Spanish-led initiatives for patients, or mentorship of underrepresented medical students and residents. She is passionate about equitable care, noting that her community has always been her motivation.

Of distinction, she is currently co-leading a YouTube project aimed at advancing medical education in the obstetric Spanish-speaking community. One of the videos she recently published was titled “Parto por Cesárea: 13 Preguntas Frecuentes,” which was produced as a way to address common questions and myths surrounding cesarean delivery. When describing her work, she notes, “These topics and procedures, often misconstrued and surrounded by negative cultural myths in our communities, have the potential to be lifesaving in the critical peripartum period. Soon we will also be leading Spanish language courses, educating patients about how they have the potential to make childbirth safer.”

Dr. Martinez is an active member of several professional organizations and is a recipient of a 2023 ASA mentor/mentee grant to design and lead Spanish epidural classes to Stanford's underserved population, which makes up about 30-40% of their obstetric cases. With less than 2% of physicians being Latinos, her work is incredibly important and will continue to positively impact and optimize safe care for Latinos everywhere – even beyond her own institution and state.

OUTSTANDING OBSTETRIC ANESTHESIOLOGIST FELLOW

Dr. Andrew Sprowell recently completed his obstetric anesthesiology fellowship at Beth Israel Deaconess Medical Center, where he has demonstrated his passion through diverse contributions to the field, including research, teaching, and complex clinical care.

At the 2023 SOAP Annual Meeting, members attended his oral presentation, “Low Dose Intrathecal Morphine is Inferior for Post-Cesarean Analgesia.” This work has now been written as a manuscript and submitted for publication. Currently, he is a co-investigator on the clinical research project titled, “Comparison of antiemetics in cesarean delivery.” His contributions have not gone unnoticed. He was recently awarded the “Clinical Trainee Research Award” by the Department of Anesthesia, Critical Care and Pain Medicine at BIDMC for his incredible contributions to the field of obstetric anesthesiology and his department.

ASA COMMITTEE ON OBSTETRIC ANESTHESIA UPDATE

I am grateful to SOAP President, May Pian-Smith, for attending our in-person ASA Committee on Obstetric Anesthesia (CObA) meeting at the ASA Annual Meeting on October 16th, along with SOAP Executive Director, Melissa Wilson, and SOAP Program Manager, Christina Tenorio– thank you for sharing and supporting our common goals.

On October 18th, the ASA House of Delegates approved CObA's 2023 statement proposals with very positive comments. Approved statements include the [Statement on Pain During Cesarean Delivery](#), [Statement on Neurologic Complications of Neuraxial Analgesia/Anesthesia in Obstetrics](#), and [Statement on Neuraxial Medication Shortage and Alternatives](#), available for free to all on the ASA website. Please read and share these and other important ASA CObA resources with your colleagues.

An estimated 15% (or higher in some prospective studies) incidence of patients experience pain during cesarean delivery– addressing this should be the #1 goal of our obstetric anesthesia community in 2024. The [ASA Statement on Pain During Cesarean Delivery](#) covers recognition and acknowledgment of intraoperative pain, and the domains that can affect the incidence and severity including preoperative assessments, strategies to minimize risk of inadequate neuraxial anesthesia, suggested supplementation of inadequate surgical anesthesia, the conversion and conduct of general anesthesia administration, recommendations for follow-up/referral and some suggested Quality Improvement metrics.

The [ASA Statement on Neurologic Complications](#) of neuraxial techniques addresses the most feared and fortunately rare neurologic injuries, whether associated with anesthesia or obstetric-related/childbirth processes. Some helpful tables guide all health care practitioners in assessing post-partum patients and escalating care for imaging and neurologic/neurosurgical consultations when needed. The statement offers recommended best practices, including monitoring, addressing issues of informed consent and patient engagement.

Drug shortages have been ongoing for over a decade, with permanent relief unlikely in the short or intermediate time frame. The [ASA Statement on Neuraxial Drug Shortages](#) offers guidance on substitutions with equivalent medications and dose ranges, to serve as a starting frame of reference, adaptable for your local practices and institutions. Note that many commonly used medications may or may not have specific FDA approval for these indications, and administration of any medication is the sole decision of the individual practitioner.

ASA CObA is working with the Committee on Performance and Outcomes Measures to develop Obstetric Outcomes Metrics. ASA previously approved the CObA [Statement on \[Obstetric\] Quality Metrics](#) in October 2022 – another helpful source of information that can guide the development of quality metrics at your own institution.
